The BPI Justice Reform team advocates for reducing the size of the criminal legal system and eliminating the racial disparities that permeate it. Utilizing the principle that those closest to the problem are the experts in the solution, we work in coalition with a wide variety of stakeholders to advance our decarceration and supportive reentry work.

Our decarceration work is focused on government policies and community campaigns that reduce the rate of imprisonment and the number of people held in custody or under custodial supervision. We use a two-fold approach to doing this work: rethinking prisons and releasing or diverting people from prison.



#### **RETHINKING PRISONS**

BPI partners with the **Illinois Coalition for Higher Education in Prison** and the **Freedom to Learn Campaign** to help with the expansion of quality college-in-prison programs across Illinois. These efforts have included:

- researching and drafting briefings for advocates and legislators
- development of communications strategies for various campaigns
- strategic planning for coalitions



#### RELEASING/DIVERTING

We support policies and legislation that advance sentencing reform, decriminalization, and mechanisms of release, as well as advocating for the increased use of executive clemency. We do this work in collaboration with key advocacy organizations that work closely with impacted people and their families. BPI has provided public education on drafting clemency petitions; representation of an incarcerated individual serving an excessive sentence; consulting with advocates regarding legislative strategy; and drafting of materials for subject matter hearings before the Illinois General Assembly.



# PARTNERSHIP FOR HOUSING ACCESS

This pilot program provides Housing Choice Vouchers to graduates of the Circuit Court of Cook County Drug Court Rehabilitation Alternative Probation (RAP) program, in partnership with the Housing Authority of Cook County and TASC (Treatment Alternatives for Safe Communities). Justice-involved individuals commonly face a lack of safe and affordable housing and needed support services, and this pilot program seeks to fill a critical void in reentry support.

#### THE CHICAGO 400 ALLIANCE

The Chicago 400 Alliance is dedicated to providing policy support to formerly incarcerated individuals affected by Illinois residency restrictions. BPI has supported events to raise awareness of the 1,400 people incarcerated past their release date as a consequence of residency restrictions. In partnership with the Chicago 400 Alliance and other advocates, BPI has advanced changes to address these restrictions.

BPI's Police Accountability Program works to enact systemic police reforms in Chicago and to ensure that those most directly affected by the reforms play an active role in developing them.

Since 2016, BPI has provided extensive support to the **Grassroots Alliance for Police Accountability (GAPA)**, a coalition of community-based organizations that has developed and advocated for an ordinance that fundamentally reimagines the relationship between the Chicago Police Department and the communities it serves. This ordinance would create new partnerships to bring police officers and residents together to build mutual trust and increase public safety at the neighborhood level, strengthen the police accountability system, and give civilians a powerful new role in police oversight.






# A CITYWIDE CIVILIAN COMMISSION

BPI has provided support to the Grassroots Alliance for Police Accountability (GAPA) as it worked with aldermen and City of Chicago officials to introduce an ordinance to create a citywide civilian commission. The commission will advance systemic police reform by playing a key role in selecting leaders, including the Police Superintendent, developing strategic goals and priorities for the Police Department, and working with the Police Department to ensure policies and priorities are rooted in best practices and grounded in the needs and values of the community.

In the wake of the police killing of George Floyd, with worldwide attention focused on oppression and police brutality, GAPA leaders and many aldermen felt it was necessary to strengthen the proposed ordinance, and BPI has worked intensively with GAPA leaders to develop additional provisions to increase accountability and build trust.

#### WORKING TO ADDRESS BARRIERS TO REFORM IN POLICE CONTRACTS

BPI is working with other advocates to eliminate contract provisions that make it harder for people to report police misconduct and easier for police officers to lie about it, and that require officials to ignore and destroy evidence of police misconduct.



# HOUSING

Since 1970, BPI lawyers have represented public housing residents and applicants in the seminal public housing desegregation lawsuit, *Gautreaux v. Chicago Housing Authority*.

Through *Gautreaux*, we have for 50 years been working to break down the unconstitutional racial segregation and economic isolation that produced what may once have been the worst public housing system in the nation. Over the past year we have worked to ensure that CHA adheres to its commitments in the 2019 Gautreaux Settlement Agreement to develop public housing and manage its waitlists in ways that maximize access to public housing across the city.

# COMMUNI DEVELOPMEN **BPI 2020 ANNUAL REPORT**

#### The Gautreaux Settlement Agreement

successfully focused the Chicago Housing Authority (CHA) on achieving the development commitments it made in the 2019 Settlement. With a higher level of cooperation from both City and State funders, new phases of housing development are well underway at more mixed-income sites than has been true since the Great Recession.

In 2019 and 2020 new **CHA family housing** was completed in:

- Lathrop Homes
- Roosevelt Square
- Washington Park
- Rogers Park
- Albany Park
- Logan Square
- Belmont Cragin neighborhoods

CHA has completed a new **Family Resource Center** in Altgeld Gardens, complete with a new
Chicago Public Library that includes community
space and a state-of-the art childcare center that
increases the number of children that can be
served in the Altgeld community.

#### **INITIATIVES**

Over the coming year, BPI will be exploring strategies to increase the success of existing CHA mixed-income developments to provide inclusive, welcoming communities across a broad spectrum of incomes.





# EARLY CHILDHOOD

BPI launched the Altgeld-Riverdale Early Learning Initiative in 2012 as a community-driven effort to build a comprehensive and coordinated early childhood system that supports children from birth to age eight in the Altgeld-Riverdale community on Chicago's Far Southeast Side.

The engine of this program is the Altgeld-Riverdale Early Learning Coalition, a network of over two dozen residents, community organizations, social service providers, early learning centers and on-site elementary schools, as well as key government agencies such as the Chicago Housing Authority, the Chicago Park District, and Library. BPI is the Coalition's ongoing convener, project manager, and facilitator.






Despite the pandemic, the programs of the Altgeld-Riverdale Early Learning Initiative have pressed on, pivoting to online platforms to address the needs of families and children through a continuum of evidence-based interventions.


When BPI's work began in Altgeld in 2012, there was no mechanism in the community for residents and organizations to collaborate on early childhood issues. Today, the Initiative's keystone Altgeld Riverdale Early Learning Coalition continues to meet monthly, bringing together all the major stakeholders who touch the lives of young kids. It continues to be a place for effective collaboration, community problem solving, and information sharing, all while continuing to provide a robust array of programs for kids from birth to age eight.

The Early Learning Coalition has played an important role in the pandemic response by providing a forum for all the major community stakeholders to share COVID-related information and services. Through monthly meetings, schools, child care centers, the health clinic, social service providers, CHA, the library, the park district, residents, and others share resources and strategize around COVID-related needs.

Our status as a well-known, well-organized, and trusted community-based coalition made the Early Learning Coalition one of just a handful of community collaborations to receive funding through Illinois Action for Children to provide emergency resources to families in need during the Coronavirus pandemic.

BPI has also embarked on a new strategy for prekindergarten enrollment in the time of COVID. BPI engaged with partners to create a pre-k enrollment campaign specifically designed for the Altgeld-Riverdale community and designed to address concerns and barriers specific to COVID. Using a human-centered design framework, we have worked with parent ambassadors to host focus groups and interviews with families and early learning program providers, talking through effective messaging regarding enrollment and understanding barriers to enrollment that could be addressed in the marketing materials. The result is a menu of materials that reflect what caregivers and stakeholders believe will be truly useful and impactful.


